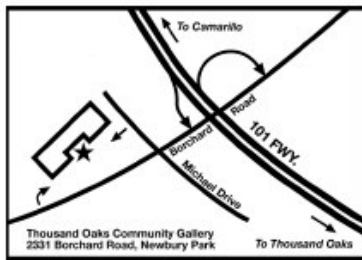

**Annual Open Juried Art Show
ELIGIBILITY AND CONDITIONS**

- Open to all artists residing in Ventura, Santa Barbara, Los Angeles, Orange and San Luis Obispo Counties.
- Original artworks created after January 1, 2008.
- Eligible Categories:
 1. Watercolor
 2. Oil and Acrylic
 3. Mixed Media, Collage, Mono-Prints
 4. 3D: Sculpture, Woodwork, Metal, Glass, Ceramics
 5. Pastels, Pencil, Charcoal, Drawings
 6. Photography, Computer Generated Art
- Maximum framed dimensions must not exceed 72” x 72” x 3”, have wire hangers, and weigh no more than 50 pounds. 3D work must not weigh more than 100 lbs. and must fit through a 36” wide door.
- Work that is wet or has saw tooth hangers is not eligible.
- All free standing work must have its own base and secure support.
- Assemblage art and other large works must be set up by the artist at a time designated by the hanging committee.
- Works previously exhibited with TOAA and supervised works are not eligible.
- A food or cash donation is asked of all accepted entrants for the reception. TOAA members are required to sit the show.

DEADLINE

Images on a CD, along with entry forms and fees, must be **received** by Friday, January 8, 2010. By entering, you allow your work to be reproduced for publicity.

SENDING ENTRIES

Images are to be sent on CD. Artists should submit one image per work for a maximum of three works. 3D work may have three images per work. Label each image with the title of the work and artist's name (i.e. Trees_Crowe). Indicate on the paper entry form the title, dimensions, medium and year completed for each work.

Mail your images on a CD, completed entry form, entry fee, and one #10 self-addressed sufficiently stamped envelope to:
